The proposed technology should be an approved one by the Central Pollution Control Board (CPCB). If suchitwa mission founds that the proposed technology is not compatible with existing rules of the state, the same shall be outrightly disqualified.

Suchitwa Mission is pleased to announce our intention to procure state-of-the-art non-biodegradable waste management machineries and technologies to enhance our waste management capabilities. We are inviting expressions of interest from eligible and reputable suppliers and manufacturers who specialize in innovative technologies suitable to the prevention or reduction of plastic marine litter pollution.

Overview

Suchitwa Mission is the nodal agency of the Government of Kerala under the Department of Local Self Government (LSG) to provide technical and financial assistance to the Local Self Government Institutions (here after expressed as LSGIs) in the sanitation and waste management sector utilizing assistance from Central and State Governments. Suchitwa Mission is committed to sustainable environmental practices and responsible waste management. As part of our ongoing efforts to reduce our environmental footprint, we are seeking advanced technology options, suitable to prevent or reduce plastic marine litter pollution.

Background

Up to 19% of plastic debris that ends up in the ocean comes from rivers, with 88–95% of those rivers coming from eight in Asia and two in Africa, according to Lebreton et al. Sea-based sources contributing to marine plastic litter are estimated to account for 1.75 million tons of a total 12 million tons entering the oceans each year, with about 1.15 million tons of fishing litter and 0.6 of million tons of shipping litter. Only 1% of marine plastics are found floating at or near the ocean surface, with a global concentration of less than 1 kg/km2 on average.

A group of technologies have been developed to recover plastic from harbors, lakes and areas of the ocean within easy reach of land. These include autonomous, floating trash collection devices, such as

Seabin, that return to shore when full, and passive trawling systems, such as Thomsea, that are attached to fishing boats.

The technologies suitable to the prevention or reduction of plastic marine litter pollution are called 'solutions'. The Trash Wheel and Storm X technologies are considered by our experts to be the most promising. It is installed in strategic upstream locations, such as rivers, ports, marinas and city foreshores. These solutions require little manpower and can be installed, maintained and operated with unskilled manpower. River cleanup technologies such as this capture plastic waste before it enters the oceans.

Scope

Technologies for the detection and capture of litter and integrated waste management solutions comprising several steps along the value chain were also considered. Being a major source of marine litter, solutions to tackle riverine and beach litter were included, too. Technologies related to wastewater treatment or the impact remediation of marine litter were not considered. Primary microplastics (e.g., from tire abrasion or textiles) are not within the scope. It targets unmanaged waste before they enter water bodies or oceans. Management of the collected waste shall be adhered to the prevailing waste management rules and regulations.

- The proponent shall work with the concerned LSGI, irrigation dept, by entering agreement with them.
- The proposed system shall be a passive/ stationary, active technology which collects both floatable and non-floatable trash (up to 5-mm in size) into a collection netting system from flowing waterways, or by capturing stormwater runoff.
- The installation shall be scalable, according to local requirements.
- The system should be closely monitored and certified to ensure full traceability of the "social" plastics.
- The proponent shall have its own facility or leased land facility for drying the wet waste collected from water bodies.
- The recyclable waste collected shall be channeled to recycling companies or final disposal facilities, cost involved shall be met by the proponent.
- The bio waste collected, if any, from the system installation point shall be handed over to LSGI for further processing, cost involved shall be met by the proponent.
- If the water body stretches need to be cleared before installation of the systems, the same shall be worked out by the proponent in association with the concerned irrigation dept.

We invite qualified agencies to provide solutions that encompass the following aspects, but are not limited to:

• Design and construction of innovative technologies suitable to the prevention or reduction of

plastic marine litter pollution.

- Establishment of a marine litter pollution prevention system with a revenue generation mechanism through reselling waste collected.
- Handle, manage and dispose of any output, residue, left over, products, effluents, and emissions in the process in accordance with local and national rules and regulations.

Further, the technology proposed to be used should be economically viable, suited to the local conditions, and environmentally compliant as per the SWM Rules, 2016 and waste management guidelines issued by the state government as amended from time to time.

Eligibility and Qualifications:

- We invite eligible agencies, including but not limited to service providers, startups, suppliers, and technology providers, with a proven track record in developing and delivering efficient technologies suitable to the prevention or reduction of plastic marine litter pollution with a registered office in India (Company incorporation certificate shall be submitted).
- The proponent shall have its own or leased vehicle facility and manpower for the purpose. The vehicles used shall be covered or especially designed for this purpose. And the vehicles used shall be registered under the KSPCB portal(if applicable).
- The agency engaged in shall have EPR registration(if applicable).
- The waste collection agency shall possess a minimum 2 years valid MOU between an authorized waste disposal plant.
- Average annual turnover of the company over the last three years should be 15 lakhs (CA Audited account statement for the last 3 yrs shall be submitted).
- The agency should not be blacklisted by the Central/ State Government or PSUs (Self declaration shall be submitted).
- The agency shall be a registered firm with valid Goods and Service Tax number (GST registration certificate shall be submitted).

Details to be submitted

- 1. Technology brief: Self explanatory technical proposal on the systems involved, with detailed process flow charts, relevant photos of the system/ technology/ machine required for the systems installed, requirements for functioning of the technology.
- 2. Company profile :- Copy of company registration certificate, GST certificate, details of staff.
- 3. Business plan:- Brief on business involved/ carried, proposal on the average cost per ton for collection and recovery for all systems, including capital and operational costs but excluding any

costs associated with downstream processing.

- **4.** Documents to prove experience in the field: Documents (agreement copies and completion certificates) to prove experience in this field (minimum 2 projects).
- 5. Documents to prove the ownership / lease ownership (Minimum 2 years) of land required for drying the waste collected from water bodies.
- **6.** Minimum 2 years valid agreement with non bio waste processing/ co processing/ disposal facilities.
- 7. The last two years, CA audited balance sheets and account statements.

Evaluation Process:

The evaluation of expressions of interest will be conducted by Suchitwa Mission. Shortlisted candidates will be invited to participate in the technical review meeting. Once after technical review, the eligible agencies shall be empaneled.

General Information for Respondents

- 1. The purpose of this EoI is to solicit information on innovative technologies suitable to the prevention or reduction of plastic marine litter pollution. At the same time this EoI provides the opportunity for companies/ agencies to assist Suchitwa Mission in gathering technical information pertaining to setting up of systems/ facilities for prevention or reduction of plastic marine litter pollution in an environment friendly manner.
- 2. This EoI process is undertaken by Suchitwa Mission for the purpose of receiving data and information for planning purposes, and is a request for competitive proposals; therefore, responses to this notice will be considered offers and shall be accepted by Suchitwa Mission to form a binding contract.
- 3. This EoI does not constitute a solicitation or a promise of a solicitation in the future and shall be construed under any circumstances as a prerequisite or pre qualification procedure. As such, this EoI is to be considered as a request for proposals or as a tender or any Procurement Action. This EoI shall not, under any circumstances, constitute any commitment on Suchitwa Mission to negotiate with any or all interested parties, to enter into any agreement for the provisions of services mentioned above at any stage.
- 4. Moreover, to preclude any doubt, it is emphasized that Suchitwa Mission shall have the right to reject, in whole or in part, any opinion, conclusion or information delivered to it through this EoI. Suchitwa Mission shall also have the right to use the information presented and/or submitted to it

- for the purpose of planning and preparing a tender or any other procedure, should SUCHITWA MISSION decide to implement one.
- 5. Suchitwa Mission shall not be bound to accept and/or consider any response and it does not undertake herein any commitment whatsoever towards any of the interested parties. Suchitwa Mission may ignore any response which lacks information or has unclear details. The firm may be called to give presentations before a committee.
- 6. SUCHITWA MISSION may also decide to set aside a period of time to gain such further information and visit their facilities of any or all the proposers.
- 9. SUCHITWA MISSION may wish to share submitted information with outside technical experts for evaluation assistance in which case they will be informed about the privileged nature of the information. However, if a submitter wishes their information to be made available only to Suchitwa Mission, a prominent label/watermark stating "for Suchitwa Mission" must be placed on each such page and information be specifically marked as confidential.
