ORDER

As per the letter read as 1st paper above, Mother Sanction for an amount of Rs.1000 Lakh has been issued for Swachh Bharat Mission (Grameen) for the FY 2026-27 in the SNA SPARSH Module of PFMS.

2 . As per the letter read as 2nd paper above, the Executive Director, Suchitwa Mission informed that budget allocation available for the FY 2026-27 under SBM Gramin head of accounts is as tabulated below (amount in lakh);

3. In the above context, the Executive Director, Suchitwa Mission has requested that an amount of Rs 1500 lakh be allocated from state share head of account and balance of Rs 177.96 lakh be re-appropriated from central share head of account to meet the requirements.

4. Government have examined the matter in detail. As per the Government Order read as 3rd paper above, sanction has been accorded for the re-appropriation of 1,77,96,000/- (Rupees One Crore Seventy Seven Lakh Ninety Six Thousand Only) to reallocate funds for the utilization of the Central Assistance sanctioned and its corresponding State Share from the single budget line of State Share in accordance with the fund flow mechanism devised for the newly introduced SNA-SPARSH system for the implementation of the scheme Swachh Bharat Mission (Grameen).

5. In the above circumstances, Government are pleased to sanction an amount Rs.16,66,66,000/- (Rupees sixteen crore sixty six lakh sixty six thousand only) as central share and matching state share for the implementation of projects under Swachh Bharat Mission (Grameen) for the year 2026-27.

6. Sanction is hereby accorded to the CCO of the Head of account - Principal Director, LSGD to allocate the amount to the SCO - the Executive Director,

Suchitwa Mission to distribute the funds to Local Self Government Institutions as per the guidelines of Swachh Bharat Mission (Grameen).
