ORDER

As per the Government Order, read as 1st paper above, Administrative Sanction was accorded for the release of an amount of Rs. 30 Crore under the H/A – 2515-00-101-68 - Suchitwa Keralam (Rural) and Rs. 20 Crore under the H/A – 2217-80-800-71 - Suchitwa Keralam (Urban) for the implementation of Plan Schemes of Suchitwa Mission for the year 2025 - 2026.

2. As per Government Order, read as 2nd paper above, sanction was accorded for the release of Rs.10.5 Crore (Rupees Ten Crore and Fifty Lakh Only) from the H/A 2515-00-101-68-P [Suchitwa Keralam - Rural] and Rs 7 Crore (Rupees Seven Crore Only) from the H/A 2217-80-800-71-P [Suchitwa Keralam - Urban] respectively, as first installment of funds for the implementation of Plan Schemes of Suchitwa Mission for the financial year 2025-2026.

3. Executive Director, Suchitwa Mission, as per the letter read as 3rd paper above, has now requested for release of the second installment under the H/A 2515-00-101-68 [Suchitwa Keralam - Rural] along with enhancement of the BAMS ceiling limit.

4. Government have examined the matter in detail and are pleased to accord sanction for the release of an additional amount of Rs. 3 Crore (Rupees Three Crore Only) from the H/A 2515-00-101-68-P [Suchitwa Keralam -Rural] for the implementation of Plan Schemes of Suchitwa Mission for the financial year 2025 - 2026 by enhancing the ceiling limit of

the respective Head of Account, subject to the condition that the proposal for the next installment should be provided with full details of the required amount, Reconciliation Certificate of accounts and the utilisation certificate of the amount received so far.
