Inviting Expression of Interest (EoI) for Empaneling agencies as Service provider for Installation and Operation & Maintenance of Modern Gas Crematorium (Furnace & Chimney) using LPG as Fuel

Suchitwa Mission is the technical agency of Government of Kerala under the Department of Local Self Government authorized to provide technical and financial assistance to the LSGIs for sanitation and waste management schemes utilizing assistance from Central and State Governments.

Suchitwa Mission decided to invite expression of interest (EoI) for empaneling more agencies as service provider for installation and operation & maintenance of modern gas crematorium (Furnace and chimney) using LPG as fuel.

EMPANELMENT OF AGENCIES

3. This is not an invitation to tender. Full tendering procedure will be applied to selected firms prequalified and found capable of executing the project. Only shortlisted firms will be contacted for the tender process. Nothing in the advertisement shall be construed to be a commitment on the part of Suchitwa Mission. Suchitwa Mission does not guarantee to proceed further than the EoI, this invitation for EoI being neither an agreement nor an offer for award of work.
4. This EoI includes statements, which reflect various assumptions and assessments arrived at by the SUCHITWA MISSION in relation to this EoI. Such assumptions, assessments and statements do not purport to contain all the information that each agency may require.
5. Suchitwa Mission is pleased to announce our intention to enlist the service providers for installation and operation & maintenance of modern gas crematorium (Furnace and chimney) using LPG as fuel. We are inviting expressions of interest from eligible and reputable service providers who specialize in providing service to the LSGIs in above mentioned area.

Scope of Work

The main scope of this EoI is to identify more experienced and competent agencies as service providers for installation and operation & maintenance of modern gas crematorium (Furnace and chimney) using LPG as fuel.

- The proponent should be capable of giving technical suggestions, installation of modern gas crematoriums per Government/ Suchitwa mission approved specification for crematorium furnace & chimney, Pollution control systems and safety measures, all allied mechanical components and related civil works such as foundation for furnace & chimney, ETP, ash pit etc. complete for the successful functioning of crematorium.
- The agencies selected shall analyze the emission standards of crematorium after the completion of the trial run.

- The service provider has to submit a letter of satisfaction to the concerned LSGI on the functioning of all the modules and on the performance of the total unit.
- The proponent shall follow proper guidelines as per Kerala Municipal & Panchayath Building rules, Kerala Panchayath Raj (Burial and Burning Grounds) Rules, Kerala Municipal Acts and norms as prescribed by KSPCB.
- The empaneled agencies shall be engaged for the task by the LSGIs through prevailing tender procedures.

A technical Committee constituted to evaluate the EoIs shall evaluate the technical knowledge, experience, expertise, competency etc. of the agency in this field. The applicant agency shall do a technical presentation to prove their credentials before the technical committee. Copies of all documents to prove experience, expertise and manpower, certifications/ appreciations, work order received so far may also be enclosed along with the application.

Eligibility Criteria

1. The interested entity should essentially meet the following eligibility criteria:
 - a. The agency must possess minimum 3 years' experience, expertise and manpower in installation and operation & maintenance of Modern Gas Crematoriums.
 - b. The proponent should be a registered firm with valid GST number for the line of business the entity is engaged in.
 - c. Audited balance sheet and annual report for the last two years (2021-2022, 2022-2023) should be submitted.
2. The required documents such as technical design of the Modern Gas Crematorium, its performance details along with explicitly supporting the past experience, list of existing and past clients with details of services offered, details of similar projects executed, with copies of agreements/ work order (minimum 3 nos), completion/ satisfaction certificates (minimum 3 nos), CVs of key personnel and other related details to verify all eligibility criteria must accompany the EoI.
3. The agency must comply with all the guidelines and strategies published by Suchitwa Mission, guidelines as per Kerala Municipal & Panchayath Building rules, Kerala Panchayath Raj (Burial and Burning Grounds) Rules and norms as prescribed by KSPCB and Government of Kerala related to Crematorium construction and management.
4. While selecting the agency, weightage shall be fixed for government registrations, technical knowledge, Certifications received for proposed technologies, experienced manpower etc.

Evaluation Criteria

The evaluation of expressions of interest will be conducted by Suchitwa Mission. Shortlisted candidates will be invited to participate in the technical review meeting. Once after technical review, the eligible agencies shall be empaneled.

Preparation for submission of EoI

1. The entity/bidder shall ensure that it fulfills the eligibility criteria and other essential conditions.
2. The EoI complete in all respects must be submitted together with technical proposal and other requisite information and annexure(s). The EoI should be free from ambiguity, change or interlineations. Incomplete EoI will not be considered and is liable to be rejected without making any further reference to the entity.
3. The EoI shall be duly signed on each page by a person authorized by the entity. Documents of the entity authorizing such person must accompany the EoI. Suchitwa Mission reserves the right to reject outright any EoI unsupported by proof of the signatory's authority.
4. The included Annexures I, II, III & IV shall also be attached along with technical proposal for furnishing details to evaluate the agency's competency in the field, Details of work done, completion certificate, work agreement, work order for each works shall be attached.
5. Audited Balance sheets for the last 2 consecutive years to be furnished along with the application.
