EXPRESSION OF INTEREST FOR EMPANELMENT OF COMPANIES/ NGOS/ ORGANIZATIONS PROVIDING TECHNOLOGIES SUITABLE FOR BIOMINING/ BIO-REMEDIATION OF LEGACY WASTE AT THE DUMPSITES IN KERALA.

1. INTRODUCTION

Suchitwa Mission is inviting expressions of interest from esteemed companies, NGOs and organizations involved in legacy waste management for the empanelment process to conduct biomining of legacy waste at the dumpsites in Kerala.

The focus of this endeavor is to establish a comprehensive Design-Build-Operate (DBO) framework for efficiently manage legacy waste in the dumpsites in local bodies across Kerala. We believe that your expertise and commitment to sustainable practices align perfectly with our mission to address the challenges associated with legacy waste management.

We invite entities with a proven track record in Bio remediation, to submit their Expression of Interest (EOI) for consideration. Empanelment criteria include, but are not limited to, experience in similar projects, financial stability, technological expertise, and a commitment to sustainability. The submission should include a detailed profile of the entity, a summary of relevant experience, proposed methodologies, and any innovative concepts that could enhance the efficiency of the legacy waste management System.

We are inviting expressions of interest from eligible and reputable suppliers and manufacturers who specialize in innovative solutions for legacy waste processing and management.

3. Overview:

Suchitwa Mission is the nodal agency of the Government of Kerala under the Department of Local Self Government (LSG) to provide technical and financial assistance to the Local Self

Government Institutions (here after expressed as LSGIs) in the sanitation and waste management sector utilizing assistance from Central and State Governments. Suchitwa Mission is committed to sustainable environmental practices and responsible waste management. As part of our ongoing efforts to reduce our environmental footprint, we are seeking advanced legacy waste management technologies and machineries to efficiently process and handle legacy waste.

We are seeking expressions of interest from experienced and qualified agencies who can contribute to the successful realization of this project.

4. Scope of Work:

Remediation of legacy dumpsites involves various activities such as waste characterization, quantification of waste to be remediated, excavation works to open the dumps, stabilization of the waste, screening and sorting to segregate the waste fractions, forward linkage of recovered materials, make necessary arrangements for prevention of fire hazarad at the site during the Bio remediation operation and scientific disposal of rejects as per the CPCB guidelines.

We invite qualified agencies to provide solutions that encompass the following aspects, but are not limited to:

- Design and construction of legacy waste processing plant at various dumpsites in Kerala.
- Establishment of a plant with a revenue collection mechanism through tipping fees imposed on the LSGI for the service of processing the legacy waste.
- Ongoing operation and maintenance of the waste management system.
- Handle, manage and dispose any output, residue, left over, products, effluents, and emissions in the process in accordance with local and national rules and regulations.

Further, the technology proposed to be used should be economically viable, suited to the local conditions, and environmentally compliant as per the SWM Rules, 2016 and legacy waste remediation guidelines issued by the state government of as amended from time to time.

Interested companies/ applicants are requested to furnish the following information and documents to prove the same to Suchitwa Mission:

5. Eligibility and Qualifications:

- We invite eligible agencies with a proven track record or having a comprehensive proposal in hand in developing and delivering legacy waste management solutions with a registered office in India (Company incorporation certificate shall be submitted).
- Average annual turnover of the company over the last three years should be 15 lakhs (CA Audited account statement for the last 3 yrs shall be submitted).
- The agency should not be blacklisted by the Central/ State Government or PSUs (Self declaration shall be submitted).
- The agency shall be a registered firm with valid Goods and Service Tax number (GST registration certificate shall be submitted).
- PCB consent to operate (for experienced service providers).

6. Submission Details:

Interested parties are requested to submit their expressions of interest to Suchitwa Mission. The submission window will be open in a continuous basis. The submission shall be made in both electronic and hard copy format. The submission should include required documents to prove the following:

- 1. Technology brief including schematic diagram, process flow, photos of previous projects.
- 2. Experience in the field.
- 3. Relevant photos of the system/ technology/ machine (existing/proposed)
- 4. Details of machinery used for Bio remediation.
- 5. Average processing fee.
- 6. Environment management plan (Existing models testimonials to prove the claims results shall be submitted for existing plants).
- Emissions (indicate type of pollutants, emission levels, emission control technologies in place).
- Inert waste (indicate quantity generated as % of input stream, composition, on- site/ offsite disposal mechanism in place).
- Other waste (indicate quantity generated as % of input stream, composition, on- site/ off-

site disposal mechanism in place).

- Odour (describe odour management plan in place).
- 7. Final disposal destination and agreement with processing/coprocessing facilities.

7. Evaluation Process:

The evaluation of expressions of interest will be conducted by Suchitwa Mission. Shortlisted candidates will be invited to participate in the technical review meeting. Once after technical review, the eligible agencies shall be empaneled.

8. Procurement Method:

The empaneled agencies capable of processing legacy waste can participate in tenders invited by the LBs to manage legacy waste at the dumpsites in Kerala. Local Bodies may also decide to negotiate directly with the agency, based on the land area requirements/ processing fees quoted in this EoI and enter into agreements with the empaneled agencies.

9. General Information for Respondents

- 1. The purpose of this EoI is to solicit information on legacy waste management technology. At the same time this EoI provides the opportunity for companies/ agencies to assist Suchitwa Mission in gathering technical information pertaining to setting up of Plants/ Setup for processing of legacy waste in an environment friendly manner.
- 2. This EoI process is undertaken by Suchitwa Mission for the purpose of receiving data and information for planning purposes, and is a request for competitive proposals; therefore, responses to this notice will be considered offers and shall be accepted by Suchitwa Mission to form a binding contract.
- 3. This EoI does not constitute a solicitation or a promise of a solicitation in the future and shall be construed under any circumstances as a pre-requisite or prequalification procedure. As such, this EoI is to be considered as a request for proposals or as a tender or any Procurement Action. This EoI shall not, under any circumstances, constitute any commitment on Suchitwa Mission to negotiate with any or all interested parties, to enter into any agreement for the provisions of services mentioned above at any stage.
- 4. Moreover, to preclude any doubt, it is emphasized that Suchitwa Mission shall have the right to reject, in whole or in part, any opinion, conclusion or information delivered to it through this EoI. Suchitwa Mission shall also have the right to use the information presented and/or submitted to it for the purpose of planning and preparing a tender or any other procedure, should SUCHITWA MISSION decide to implement one.
- 5. Suchitwa Mission shall not be bound to accept and/or consider any response and it does not undertake herein any commitment whatsoever towards any of the interested parties. Suchitwa

Mission may ignore any Response which lacks information or has unclear details. The firm may be called to give presentations before a committee.
