<u>ORDER</u>

As per the Sanction Orders read as 1st paper above, the Ministry of Drinking Water & Sanitation, Govt. of India have released a total amount of Rs.78,46,20,000/- towards 1st Installment of Performance Based Incentive Grant (PBIG) under Swachh Bharat Mission (Gramin) during the Financial Year 2019-20. Accordingly as per G.O read as 2nd paper above sanction has been accorded to release an amount of Rs 66,00,00,000/- to Suchitwa Mission, by debiting the expenditure under the Head of Account 2515-00-101-

65(01) and directed the Executive Director, Suchitwa Mission to submit proposal for additional authorization for the balance fund, after utilizing the sanctioned amount of Rs 66,00,00,000/-. Suchitwa Mission has allotted the said amount to Grama Panchayats following allotment system via BAMS. But the Grama Panchayats had expended an amount of Rs.97,85,759/- only under the H/A 2515-00-101-65(01) during the Financial Year 2019-20.

2. As per the Sanction Orders read as 3rd paper above, the Ministry of Drinking Water & Sanitation, Govt. of India have released a total amount of Rs.62,93,42,000/- towards the 2nd installment of Performance Based Incentive Grant under Swachh Bharat Mission (Gramin). Subsequently, sanction has been accorded to release an amount of Rs.62,93,42,000/- to Suchitwa Mission as per G.O read as paper above, by debiting the expenditure under the H/A 2515-5th 00-101-65(01) during the Financial Year 2019-20. The Executive Director, Suchitwa Mission, as per letter read as 6th paper above has reported that though Government had sanctioned the amount, Suchitwa Mission has not received the allocation as no additional authorization was sanctioned under the Head of account 2515-00-101-65(01) during 2019-20. The Executive Director, Suchitwa Mission has therefore requested to re-allot the unspent portion of 1st and 2nd installment of Performance based Incentive Grant under Swachh Bharat Mission (G) for the year 2019-20, through additional authorization of sufficient fund under the Head of account 2515-00-101-65(01).

3. Government have examined the matter in detail. As per G.O. read as 7th paper above, a total additional expenditure to the tune of Rs.87,91,77,000/- has been authorized under the H/A 2515-00-101-65 (01)(PV) (Rs.74,66,91,000/-), 2515-00-789-98-(01)(PV) (Rs.12,24,11,000/-) & 2515-00-796-98-(01)(PV) (Rs.10,07,5000/-) for providing funds required for making allotments for the utilization of unspent portion of 1st and 2nd installment of Performance Based Incentive Grant under Swachh Bharat Mission (G) for the year 2019-20.

4. In the above circumstance, Government are pleased to reallot the 1^{st} and 2^{nd} installment of Performance Based Incentive Grant under Swachh Bharat Mission (G) for the Year 2019-20 as
