ORDER

As per the letter read as 1<sup>st</sup> paper above the Executive Director, Suchitwa Mission has submitted a proposal for administrative sanction for the scheme Viz."Suchitwa Keralam - Reconstruction of toilets damaged due to flood in schools /other water logged areas in rural areas (New Component)" for an amount of Rs.1500 lakh under Head of Account 2515-00-101-68. The other details of the Scheme is given below:-

**i. Components of the Scheme :**

The estimate is for a toilet building with 2 seats of toilet, with all necessary plumbing and sanitary fittings, including 1000 litre capacity water tank and septic tank soak pit system, provision for name board etc.

**ii. Break up of Standard Unit cost of Rs 2,00,000/- :**

- Construction of toilets Building (2 seat)with all necessary plumbing and sanitary fittings - Rs 1,49,378.71/-
- Construction of Septic Tank - Rs.17,425.14/-
- Construction of soak pit system - Rs 6415.09/-
- Lump sum for other related works & name board - Rs. 4000/-

- 12% GST for civil works and unforeseen items if any - Rs. 22,781.06/-

**iii. Period of Completion:** 1 year

**iv. Mode of Implementation:** Will be Implemented through Local Self Government Engineering Wing and monitored through District suchitwa Mission.

**v. Release of funds and details of monitoring mechanism :** Funds will be released to Local Self Government Institutions and monitored through District Suchitwa Missions.

**vi. H/A to debit the expenditure :** 2515-00-101-68

**vii. Physical Target :** 401 Sanitary complexes

**viii. Outcomes and deliverables of the Scheme :** During flood and natural calamities, lack of sanitation facility and concentration of large number of people at limited camps may lead to rapid spread of diseases. Most of the schools that run the camps do not have enough toilets. The proposal for sanitary complexes (401 Nos) will resolve this issue. The 401 Schools (including aided schools) in which toilet complex proposed to be constructed have been designated as relief camps.

2. As per the minutes read as 2<sup>nd</sup> paper above, 18<sup>th</sup> meeting of Special working Group held on 01/11/2019 has approved the scheme, "Suchitwa Keralam-Reconstruction of toilets damaged due to flood in schools / other water logged areas in rural areas" as detailed below.
