ORDER

Pre-monsoon Cleaning Campaign (Arogya Jagratha) is one of the components of the Plan Schemes of Suchitwa Mission i.e. Suchitwa Keralam (Rural) and Suchitwa Keralam (Urban), with financial outlay of Rs.1597 lakh and Rs.395 lakh

As the activities in connection with Pre-monsoon Cleaning Campaign (Arogya Jagratha), 2019 has to be started on ground at the earliest, it is highly necessary to allot sufficient funds to the Local Self Government Institutions urgently for the purpose. Therefore the Executive Director, Suchitwa Mission has requested to issue administrative sanction to the Pre-monsoon Cleaning Campaign (Arogya Jagratha) Component of Plan Schemes, 2019 urgently.
