## **ORDER**

As per G.O. read as 1<sup>st</sup> paper above Administrative Sanction has been accorded to the Plan Scheme 'Suchitwa Keralam (Urban)' for an amount of Rs.2500 Lakh under the H/A 2517-80-800-71.

- 2. As per GO.s read as 2<sup>nd</sup> & 3<sup>rd</sup> paper above sanction was accorded to the Director of Urban Affairs to draw and disburse an amount of Rs 416.67 lakh (1/6<sup>th</sup> of the plan provision Rs.2500 Lakh) under the H/A 2217-80-800-71 to Suchitwa Mission for the implementation of the Scheme.
- 3. In the context of recent flood, it was decided as per the minutes of meeting of Chief Secretary read as 4<sup>th</sup> paper above that, in case of noncommitted expenditure, all departments should re-work and re-structure their plan proposals prioritizing the works, cutting a minimum of 20% of their outlay for 2018-19, for which Administrative Sanction was already issued. Accordingly, as per G.O. read as 6<sup>th</sup> paper above revised Administrative Sanction has been issued for Suchitwa Keralam (Urban) for an amount of **Rs.2000 Lakh** under the H/A 2517-80-800-71. As per the revised Administrative Sanction Rs.333.33 Lakh each (instead of Rs. 416.67 lakh) has to be released as 1/6<sup>th</sup> of Plan Provision for Suchitwa Keralam (Urban).

- 4. As per the letter read as 5th paper above Executive Director, has requested to accord sanction for the release of Suchitwa Mission next installment of fund under Suchitwa Keralam (Urban) with permission to the D.D.O. of Suchitwa Mission to draw and disburse the amount to the PSTSB account no. 79961200000068 of Sub Treasury, Vellaymbalam. Since an amount of Rs. 416.67 lakh has already been released as 1<sup>st</sup> installment. an amount of Rs.249.99 Lakh [Rs.333.33Lakh (1st installment) + Rs.333.33Lakh (2nd installment) - Rs 416.67Lakh (1st installment already released)] has to be released as 2nd installment of Suchitwa Keralam (Urban).
- 5. Government have examined the matter in detail and are pleased to accord sanction to release an amount of Rs.250 Lakh to Suchitwa Mission, as 2<sup>nd</sup> installment for the implementation of Suchitwa Keralam (Urban) by debiting the expenditure under the H/A 2217-80-800-71-Suchitwa Keralam(Urban), with permission to Executive Director, Suchitwa Mission to draw and disburse the amount to the PSTSB account maintained by Suchitwa Mission at Sub Treasury, Vellayambalam through the D.D.O. appointed for the purpose, subject to the condition that, next time onwards, Suchitwa Mission should adopt multi layered PSTSB system.
