As per GO read as 2nd paper above—a new category of non interest bearing Special Treasury Savings Bank Account namely Plan Scheme Treasury Savings Bank Account (PSTSB) was introduced for managing the release and utilization of Plan Fund of Government Department and Agencies and the release of Plan funds to Government Departments and Government Agencies and other Organizations is permitted only to this new PSTSB Account, restricting to one account for one office. Accordingly the Executive Director, Suchitwa Mission has opened a PSTSB Account (No.799012700000068) at Sub Treasury, Vellayambalam.

As per letter read as 3rd paper above Executive Director, Suchitwa Mission has requested to accord sanction to the Director of Panchayat and Director of Urban Affairs to draw and disburse the above said amount to the newly opened PSTSB Account of Suchitwa Mission at Sub Treasury, Vellayambalam.
