ORDER

As per the G.O read as 1st above, the State Level Steering Committee was reconstituted for the formulation of State Sanitation Strategy (SSS). The Executive Director, Scuchitwa Mission vide her letter read as 4th paper above reported that under the leadership of State Level Steering Committee (SLSC), as entrusted by Government, the GIZ has prepared and submitted the SSS in consultation with ULBs and other stakeholders with the coordination from Suchitwa Mission, the nodal agency. After a series of discussions and stakeholders consultations, state sanitation strategy has been formulated and the same has been placed before SLSC for procedural endorsement and approval. In the meeting of SLSC, vide minutes read as 2nd paper above, it was observed that the SSS needed to be focused on sanitation issues such as open defecation and the problem of solid and liquid waste management. In the said meeting, comments on the drafts were also invited from State Level Steering Committee members for enrichment of state sanitation strategy. After the consideration of the suggestions, as per the letter read as 3rd above the GIZ has now completed the required updations and submitted the final draft of state sanitation strategy document and requested for according approval and endorsement of the said SSS, as the same needs to be shared with Ministry of Urban Development (MoUD), Government of India for final approval. The Executive Director, Suchitwa Mission has recommended and requested to approve and endorse the state sanitation strategy.


