ORDER

As per the decision in the meeting read as 1st paper above, the Managing Director, Kerala Water Authority submitted PER (Preliminary Engineering Report) for the rehabilitation of Sewage Treatment Plant at Kochi prior to inclusion of septage treatment for favour of sanctioning funds.

2) The Executive Director, Suchitwa Mission as per his letter read as 3rd above, recommended to accord administrative sanction for the proposal submitted by Kerala Water Authority subject to certain incorporation in the PER detailed below:-

1. Proper Sewage Collection and delivery system from tanker lorries at the site.
2. Septage collection tank for temporary storage of septage drawn from tanker lorries and for distributing the same to the treatment plant according to load variations. Collection tank so provided should be of closed type with proper suction and if required, with sufficient gas purification/bio filter system since the location of the plant is situated within residential area.
3. Anaerobic system for providing pre-treatment of septage before joining the main sewage flow.

4. Washing facility for tanker lorry with wash water conveyance arrangements to the treatment plant.
5. The detailed design prepared by the KWA may be provided to Suchitwa Mission for vetting and providing financial support.

Considering the urgency involved in the matter and the necessity of providing co-treatment facility for septage in the existing sewage treatment plant at Kadavanthra, Ernakulam and after having examined the matter in detail, Government are pleased to accord administrative sanction for the proposal of Kerala Water Authority. The expenses in this regard shall be met from the provisions available in the Annual Plan of Suchitwa Mission for supporting one model septage treatment facility in the State.
