ORDER

As per the Government Order read as 1st paper above Government have accorded sanction for the implementation of World Bank assisted Kerala Urban Service Delivery Project (KUSDP) with the objective of strengthening the institutional capacity of all Urban Local Bodies (ULBs) and to provide additional financial and technical support for waste management and sanitation sector. As per the Government Order read as 2nd paper above the Project- KUSDP has been renamed as Kerala Solid Waste Management Project (KSWMP).

2. As per the Government Order read as 3rd paper above Government have constituted a State Project Management Unit (SPMU) for KSWMP with following staff pattern with number of positions as indicated against each discipline:

- 2.Procurement Expert- 1
- 3.Environment Expert- 1
- 4.Social Development & Gender Expert- 1
- 5.Urban Sanitation & Technical Expert- 1
- 6.Monitoring & Evaluation Expert- 1
- 7.IEC Expert- 1
- 8.Finance Assistant- 1
- 9.Video Editing & Graphics Design Expert- 1
- 10.Data Entry Operator cum Multi task person- 3

3. Government of India has requested the State Government to comply with the readiness criteria before proceeding to the negotiation of the project for availing financial assistance from the World Bank. As per the letters read as 5th paper above, the Project Director, KSWMP has reported that setting up of District Project Management Units (DPMUs) in 14 districts and constitution of Project Implementation Unit (PIU) in each ULBs are two readiness criteria to be fulfilled prior to the negotiation of the Project for availing the financial assistance for the project and submitted proposals for setting up of the DPMUs and PIUs. He has also requested for the creation of two more posts namely Project Head (IT) and Project Head (Infrastructure Management) in the State Project Management Unit (SPMU).

4. Government after having examined the matter in detail accord sanction for the Creation of District Project Management Units (DPMUs) in 14 districts, Project Implementation Unit (PIU) in 93 Urban Local Bodies (ULBs) under Kerala Solid Waste Management Project and sanction posts of Project Head (IT) and Project Head (Infrastructure Management) in the State Project Management Unit (SPMU) of Kerala Solid Waste Management Project as mentioned in the tables below. Sanction is also accorded for recruitment of experts in the DPMUs, PIUs and SPMU as sanctioned below by the Committee Constituted as per the Government orders read 3rd and 4th above for recruitment of experts in SPMU.
