ORDER

As per Government Order read as 1st paper above, Government have accorded sanction for engaging project Management Consultancy (PMC) for implementing Kerala Solid Waste Management Project (KSWMP), World Bank assisted project for providing additional financial and technical support to LSGIs in sanitation and waste management sector.

- 2. As per the letter read as 2 nd paper above, the Project Director KSWMP has reported that Request for Expression of Interest (REoI) for selecting a PMC has been issued and the Evaluation Committee constituted for the purpose of evaluation of EoI has evaluated the EoIs received and shortlisted 8 firms. KSWMP has also issued Request for Proposal (RFP) to the shortlisted firms.
- 3. The Project Director, KSWMP has also reported that State Project Management Unit constituted under KSWMP is having only one Procurement Expert for evaluating the RFPs for selecting PMC, which may consist of around 600 CVs, and hence it will take more time to complete the evaluation procedure. The Project Director has requested to accord sanction for availing the services of Center for Management Development (CMD) Thiruvananthaapuram for evaluating RFPs for the selection of PMC for KSWMP, and to meet the expenditure in this regard from the funds available with Suchitwa Mission.
