ORDER

Ministry of Jalshakthi, Government of India, sanctioned an amount of Rs. 1,69,67,000/- as the Central share towards the first installment of SBM(G) Grant in Aid for the year 2020-21. As per Government Order read as 2nd paper above, Finance Department has additionally authorized an amount of Rs. 1,69,67,000/-, as the Central share towards the first installment of SBM(G) Grant in Aid for the year 2020-21.

- 2. As per the guidelines of SBM, Grant to the State will be in the ratio of 60:40. Since the State share towards the first installment of SBM(G) has not been released, as per the letter read as 3rd paper above, the Executive Director, Suchitwa Mission has requested to release an amount of Rs.1,13,11,333/- as matching State share (40%) towards the first installment of SBM(G) Grant in Aid for the year 2020-21.
- 3. As per the letter read as 4 th paper above, the Executive Director, Suchitwa Mission has reported that the budget provision available for the financial year 2021-22 is as shown below:
