ORDER

Performance Based Incentive Grant (PBIG) to the State is in the form of 100% grant from the Centre to the States, in addition to the funds released to the State for the Annual Implementation Plans (AIP). The Government of India has released Rs. 302.78 Cr to the State under PBIG in three instalments from year 2018. As per circular read as 1st paper above Government have issued guidelines for the utilization of amount allotted as PBIG. Government of India has fixed last dated for the utilization of the said grant as 31.01.2021. As per the circular and G.O read as 2nd and 4th paper above respectively, Government have issued additional instructions to Local Self Government Institutions to ensure the expenditure of more amount allocated under PBIG.

2. As per the letter read as 5th paper above, the Executive Director, Suchitwa Mission has requested to issue orders on listing the expenditure
