ORDER

As per G.O. read as 1st paper above, an additional expenditure to the tune of Rs.1,13,64,000/- was authorized under the H/A 2217-05-800-66 for meeting the administrative expenses on project preparation activities by the Kerala Urban Service Delivery Project (KUSDP) to avail the World Bank share for implementing Solid Waste Management Project. As per G.O read as 2nd paper above name of the project is changed to Kerala Solid Waste Management Project (KSWMP)

- 2. As per G.O. read as 3rd paper above, Government have released an amount of Rs.50,00,000/- to Project Director, KSWMP for the project preparation activities of KSWMP to avail the World Bank share for implementation of the Project, by debiting the expenditure under the H/A 2217-05-800-66
- 3. As per G.O read as 4th paper above, Government have accorded sanction for the creation of a State Project Management Unit (SPMU) on coterminus basis with the project period of the World Bank aided KSWMP and recruitment of Experts / Supporting personnel in the SPMU on contract basis

for a period of one year.

- 4. As per the letter read as 5th paper above, the Project Director, KSWMP has reported that anticipated amount of Rs. 63,64,002/- (Sixty three lakh sixty four thousand and two only) is required for meeting the administrative expenses of the Project. The Project Director, KSWMP has also requested to release an amount of Rs.63,64,000/- (Sixty three lakh sixty four thousand only) sanctioned as per G.O read as 1st paper above, for meeting administrative expenses of SPMU of KSWMP and also to transfer the amount to the Special TSB account maintained with the Sub- Treasury, Vellayambalam.
- 6. Government have examined the matter in detail and are pleased to release an amount of Rs.63,64,000/-(Sixty three lakh sixty four thousand only) to Project Director, Kerala Solid Waste Management Project (KSWMP) to meet the administrative expenses on project preparation activities by the KSWMP to avail the World Bank share for implementing the Project, by debiting the expenditure under the H/A 2217- 05-800-66 subject to the following conditions:
 - i. The Controlling Officer of the Head of Account shall take timely steps to regularize the additional expenditure through Re-appropriation of Savings within the Grant / Supplementary Demands for Grants before the close of the current financial year.
 - ii. The Project Director, KSWMP shall ensure that, the fund provided is utilized in an effective manner and limited to the actual and bare minimum requirements.

iii. Utilization Certificate shall be furnished to Government in time.
