ORDER

Ministry of Housing and Urban Affairs has sanctioned Rs.51.64 Cr as 1st Instalment of VGF for the implementation of Solid Waste Management DPR projects of Urban Local Bodies (ULBs). As per G.O read as 1st and 2nd paper above, Government have released Rs. 86.06 Cr (including corresponding State Share of 34.42 Cr) as detailed below.

2. 82 Urban Local Bodies have prepared DPR for SWM Project and have got approval from State Level Empowered Committee (SLEC). As per the letter read as 3rd paper above, the Executive Director Suchitwa Mission has reported that, out of Rs. 86.06 Cr released, an amount of Rs.51.97 Cr was allotted to Municipalities and Rs.4 Cr was allotted to Municipal Corporation as first instalment for the implementation of projects based on the approved DPR. A balance amount of Rs 30.09 Cr is available with state under respective Heads

as detailed below

The Executive Director, Suchitwa Mission has also reported that those Municipalities expended the amount allocated as 1st instalment almost in full have requested for further release of money for completion of their projects. Since the release of additional resources to municipalities will help in fruitful utilization of money already sanctioned, the Executive Director, Suchitwa Mission has requested to grant permission to release 2nd instalment of SBM(U) fund to all eligible ULBs who have performed well in 1st instalment utilization from the fund available with the State as 1st instalment release for DPR projects.

Government have examined the matter in detail and are pleased to accord sanction to release 2nd instalment of SBM(U) fund to all eligible ULBs who have performed well in 1st instalment utilization, from the fund available as 1st instalment release for Solid Waste Management DPR projects of Urban Local Bodies (ULBs) subject to the following conditions:
 - i.The Executive Director, Suchitwa Misison shall take necessary steps to improve the overall progress of ULBs where performance is low
 - **ii.** It shall be ensured that 1st instalment allocation is not affected on utilizing 1st instalment fund for 2nd instalment of SBM(U) fund to all eligible ULBs who have performed well in 1st instalment.
