only) towards the **Normal Allocation** (Non SCP & Non TSP), **Rs.11,76,04,000**/- (Rupees Eleven Crore Seventy Six Lakh and Four Thousand only) towards the **Scheduled Castes Component** and **Rs.1,76,61,000**/- (One Crore Seventy Six Lakh and Sixty One Thousand only) for **Scheduled Tribe Component** for the year 2020-21 from the Head of Account **2515-00-101-65** (01), **2515-00-789-98-01** and **2515-00-796-98-01** respectively.
