NOTIFICATION

INVITING EXPRESSION OF INTEREST (EOI) FROM COMPANIES/FIRMS FOR SETTING UP AUTOMATED WASTE PROCESSING UNITS (FOR PROCESSING BIODEGRADABLE AND NON-BIODEGRADABLE MUNICIPAL SOLID WASTE) AT INDUSTRIAL PARKS OF DEPARTMENT OF INDUSTRIES IN THE STATE OF KERALA

Suchitwa Mission invites Expression of Interest (EoI) from operators/companies/firms to setup and operate Automated Waste Processing Units (WPU) for processing biodegradable and non-biodegradable municipal solid waste in the land available in the various Industrial Parks under the Department of Industries in the State of Kerala. Government of Kerala has earmarked lands of area up to 1 Acre in selected Industrial Parks in this regard; a special scheme has been framed for allotment of land at concessional rates. The details are given below:

Background

With an aim to make India clean, the Swachh Bharat Mission was launched by the Government of India on 2nd October 2014. One of the key goals of the Mission is to achieve 100% scientific processing of municipal solid waste (MSW). In order to achieve this target the availability of modern waste treatment facilities with automated systems and advanced pollution control measures for various streams of waste generated is necessary. One of the key factors in setting up such facilities is availability of appropriate land. Therefore, land/plots up to 1 acre in area at Thiruvananthapuram, Pathanamthitta, Alappuzha and Thrissur Districts has been earmarked at various Industrial Parks under Department of Industries by Government of Kerala for setting up such plants. All these Industrial Parks have support infrastructure facilities such as power & water and the land will be provided at concessional rates.

Conditions and eligibility criteria

Priority will be given to operators/firms/companies as per the following criteria

- The WPU should be PLC (programmable logic controller) operated and require minimal manual intervention
- The contractor will have to set up and operate the WPU
- The WPU should process all forms of plastics - recyclable and non-recyclable
- No form of incineration or landfill would be allowed on site. All waste received should either be

- recycled or packaged/baled for onward transmission to scientific disposal centres
- Weightage would be given to WPU's with capacity to also recycle cloth garments, fabric and metallic waste
 - Weightage would be given to WPU's with the capacity to process kitchen waste and slaughterhouse waste
 - All revenues from the waste would belong to the contractor
 - The Govt. may accept a reasonable user fee
 - The contractor should ensure that there are air and water-purifying systems and any air/water released complies with PCB norms
